- Sealed or electronic bids must be submitted to the office Lekam Rural Municipality RatamataDarchula by hand/courier or through PPMO website www.bolpatra.gov.np/egp on or before 12.00 pm on 31<sup>st</sup> Oct 2023. Bids received after this deadline will be rejected.
- 6. The bidswill be opened in the presence of Bidders' representatives who choose to attend at 10:00am nov.1st 2023 at the office of Lekam Rural Municipality. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum as stated below which shall be valid for 30 days beyond the validity period of the bid.
