- 6. The bidswill be opened in the presence of Bidders' representatives who choose to attend at 10:00am 5th feb2024 at the office of Lekam Rural Municipality. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum as stated below which shall be valid for 30 days beyond the validity period of the bid .
